## PRODUCT OVERVIEW

- Albaugh SPERTO® 680 EC Herbicide is a specially formulated low volatile herbicide for selective control of various weeds in crops, pastures and non-agricultural areas as per the Directions for Use table.
- This is a PHENOXY HERBICIDE that can cause severe damage to native vegetation and susceptible crops such as cotton, grapes, tomatoes, oilseed crops and ornamentals.

Amaranthus spp, angled onion, apple of sodom, bathurst burr, black knapweed, buffalo burr, california burr, caltrop, cape tulip, capeweed, charlock, clover, colocynth, deadnettle, devil's claw, dock, fat hen, flatweed, fumitory red, galvanised burr, goosefoots, Russian knapweed, hogweed/wireweed, horary cress/whiteweed, horehound, ironweed, corn gromwell, khaki weed, lincoln weed, London rocket, lupins, melilotus/hexham scent, melons, camel, paddy, mustards, mexican poppy, mintweed, muskweed, New Zealand spinach, noogoora burr, nut grass, paterson's curse, poppy wild, ragwort, rapeseed, rapistrum, rough poppy, St John's wort, safflower, sand mustard/sand rocket, shepherd's purse, silver leaf nightshade, Stingless nettle, stinging nettle, stinkwort, storksbill/erodum, sunflower (seedlings), thistles (golden, nodding, saffron, sheep, slender, shore, soldier, spear, stemless, St Barnaby's, star and variegated), thornapple, tree hogweed, turnip weed, vetches/tares, wards weed, wild cabbage, wild garlic, wild mignonette, wild mustard, wild radish, wild sage, wild teasel and wild turnip.
