AZOXY 2SC SELECT will control or suppress the following disease on turfgrass: Fairy Ring

Apply prior to disease development. Mix AZOXY 2SC SELECT with the required amount of water and apply as a dilute spray application in 2-4 gallons of water per 1,000 square feet (87-174 gallons per acre). Repeat applications at specified intervals for as long as required. For spot treatments, use 0.4 fl. oz. AZOXY 2SC SELECT per 1 to 2 gallons of water. **DO NOT** apply more than 9.6 quarts product/acre/year (7.1 fl. oz. product/1,000 square feet/year). Apply by ground only.
