

# RETURN®XL

BROAD-SPECTRUM INSECTICIDE WITH SUPPRESSION OF SUCKING AND CHEWING INSECTS, AS WELL AS NEMATODES.



ReTurn® XL is a liquid, water soluble insecticide product to be diluted with water for control of many insects, mites and nematodes. Apply at the labeled use rates when insect populations reach locally determined economic thresholds. If needed, follow-up applications may be applied to keep pest populations within threshold limits.

All soil-applied treatments must be incorporated immediately after application to a depth of at least 2 inches by water or mechanical means. ReTurn XL should be placed in the root zone of the plant for best results.

Once the product is mixed in solution, no further agitation is needed in the tank. However, when treatments are made to cotton using oil, maintain agitation in the tank. To obtain thorough and uniform coverage, use sufficient water volume.

### FREQUENTLY ASKED QUESTIONS

#### What crop rotation or plant back restrictions does ReTurn XL have?

• Do not plant crops other than those that are registered for use with ReTurn XL within 4 months after the last application. Cover crops that are planted to build the soil or for erosion control may be planted any time, but DO NOT graze or harvest for food or feed.

#### What is the recommended spray volume for ReTurn XL?

- ReTurn XL applications may be made by ground, air or by using chemigation application equipment. Refer to the crop directions for use section for the application equipment that may be used for each crop.
- For applications made by ground, use a minimum of 5 gallons per acre of water unless otherwise directed on the label.
- For applications made by air, use a minimum of 2 gallons per acre of water unless otherwise directed on the label.
- In some cases where coverage may be difficult to obtain (e.g. dense foliage, closed canopy, waxy leaf surfaces) an adjuvant may improve performance.
