Sulfentrazone 4SC Select™ is a soil-applied selective, flowable herbicide that contains 4 pounds of active ingredient per gallon. **Sulfentrazone 4SC Select** can be used to control broadleaf, grass, and sedge weeds in established turfgrasses (seeded, sodded, or sprigged). Best control is achieved with grassy weeds when applied to grasses that are actively growing and small (pre- tiller stage). For optimum control of broadleaf weeds, applications should be made shortly after emergence.

***NOTE** Split applications give optimum control of purple nutsedge. When actively growing purple nutsedge is evident, apply as indicated below:

Cool season grasses: 2 - 4 fl. oz. **Sulfentrazone 4SC Select** per acre first application, followed by second application of 4 - 6 fl. oz. per acre. **DO NOT** exceed 8 fl. oz. total on cool season grasses.

Warm season grasses: 6 - 8 fl. oz. **Sulfentrazone 4SC Select** per acre first application, followed by second application of 4 - 6 fl. oz. per acre. **DO NOT** exceed 12 fl. oz. total on warm season grasses. Observe maximum rate per acre based on select variety, as indicated above. Allow 35 days between applications.
